7. The student has been expelled in accordance with Section 37.007 during the preceding or current school year.	Copy of expulsion records indicating cause of expulsion
8. The student is currently on parole, probation, deferred prosecution, or other conditional release.	Copy of legal document confirming parole, probation, deferred prosecution, or other conditional release
9. The student has previously reported to PIEMS as a dropout.	Copy of PIEMS report classifying students as a dropout.
10. The student is a LEP student, as defined by Section 29.052.	Copy of LPAC profile indicating LEP status (Entered by Dir. Of ESL/Bil)
11. The student is in custody or care of Dept. of Protective & Regulatory Services or has in current school year been referred to the DPRS by school official, officer of juvenile court, or officer of the law.	Copy of DPRS documentation confirming custody or referral
12. The student is homeless, as defined by the McKinney-Vento Homeless Education Assistance Improvement Act of 2001, Section 725.	Copy of records indicating homeless status (Entered by Homeless Liaison in Fed. Programs Office)
13. The student resided in preceding or current year in a residential placement facility in the district, including a foster group home.	Copy of documentation indicating residential placement in detention or substance abuse treatment facility, emergency shelter, psychiatric hospital, halfway house, or foster group home
