School Transition Services			At age 18 graduate <u>or</u> walk across the stage but DO NOT receive diploma and get services through the year he or she turns 22 (or some year in between)	Talk to teacher

<u>Legal Issues</u>			Not until child is age 18; start 4-6 months before age 18. Try your county probate court website for forms, instructions. Be ready to pay lawyer, bond and court fees. Or is limited guardianship or power of attorney more appropriate? 			After age 18, must renew guardianship annually, pay bond	Probate website for form
	Estate planning		Draw up a will. Avoid child inheriting more than \$2000 or holding bank accounts, trusts, etc over \$2000 IN HIS or HER NAME. Estate planning with a certified estate planner for ways to meet your child's needs long term.
